**OFFICE ORDER NO - 44**

Sub: Preventive measures to contain spread of COVID19 –  
Lock down imposed in Chennai – change in roster - reg.

As part of preventive measures to contain spread of COVID19 and in pursuance of orders of Ministry of Home Affairs vide No.40-3/2020-DM-I (A) dt.17.5.20 communicated by Headquarters vide circular No. 163-Estates/11-2020 dt.18<sup>th</sup> May 2020 and vide office order No.14 dated 19.05.20 this office remains fully functional with a daily roster of 50 percent of staff strength from 19<sup>th</sup> May 2020.

Taking in to account the wide spread incidence of COVID19 cases the Government of Tamil nadu, through press release dated 15<sup>th</sup> June 20, have imposed complete lock down from the 19<sup>th</sup> of June to 30<sup>th</sup> of June 2020 in Chennai and some other districts. Further, the Government of Tamil nadu have stated that all Central Government Offices in Chennai shall function with 33% of staff strength during the period of complete lockdown and such of those offices who perform essential services shall function with required strength.

Accordingly and in terms of HQ circular No.175-Estates/11-2020 Dt.12.06.20 this office will function with a daily roster of 33 percent of staff strength w.e.f.,19<sup>th</sup> June 2020 and until further orders . All officials are directed to attend office on the dates assigned for which appropriate rosters as approved by the Group officers will be maintained and circulated by the controlling sections concerned. Other instructions issued as part of Office order No.14 dated 19.05.2020 will continue to be in force until further orders.
