1. Incentive Exam- Sr. DAOs/DAOs (Gr. I) with minimum one year of regular service in the post of DAO (Gr. I) as on 01/09/2019.
2. CPD I Exam- Sr. DAOs/DAOs (Gr. I) with minimum four years of regular service in the post of DAO (Gr. I) as on 01/09/2019.
3. CPD II Exam – Successful candidates of CPD I who have passed CPD I Exam held in Aug 2015 or earlier.
4. SAS Exam(Civil Audit or Civil Accounts) – DAOs (Gr. II)/ DAs who have passed Divisional Accountant Grade Exam and Tamil language test with minimum two years of regular service in the post of DA as on 01/09/2019. Eligible candidates are allowed to appear either Civil Audit or Civil Accounts for promotion to the post of Asst Audit/ Accounts Officer. Option once exercised is final.
